





Pontifical University of St. Thomas Aquinas – Angelicum

The Pontifical University of St. Thomas Aquinas, more commonly known as the Angelicum, is a hidden gem at the heart of the Church. Tracing its roots to the 13th century and to St. Thomas Aquinas himself, the Angelicum is the pontifical university of the Dominican Order in Rome. Housed in a beautiful 16th-century cloister in Rome’s historic center and educating over 1,000 students per year from over 100 countries, the Angelicum is responsible for the formation of future leaders of all stripes, including pastors and bishops, theologians and professors, canon lawyers, heads of congregations and more.

As a pontifical university, the Angelicum is accredited by the Holy See and entrusted by it with the mission of teaching the sacred sciences to advance the Church’s evangelizing mission. True to its Dominican identity, the Angelicum forms the backbone of its educational program on the theology of

St. Thomas Aquinas, bringing his theology into conversation with modern disciplines and global challenges. In the spirit of St. Dominic, the Angelicum combines prayer and study to form its students as effective preachers of the Gospel.



Over the centuries, the Angelicum has educated extraordinary alumni, including Pope Saint John Paul II, Venerable Fulton Sheen, and many other scholars, saints, and martyrs, such as Servant of God Father Ragheed Ganni, who gave his life for his faith in 2007 in his native Iraq. Since 2000, over 180 alumni have been appointed bishops, including 46 from the United States, and 20 have been appointed cardinals.

Under the leadership of the American Dominican priest and theologian Fr. Thomas Joseph White, the Angelicum has undertaken a tremendous program of renewal in recent years. This has included renovations of the University’s historic campus, establishment of new scholarship funds for deserving students, recruitment of distinguished professors, and founding of campus institutes that bring the Angelicum’s evangelizing mission to new frontiers.

These new initiatives have been made possible through the Angelicum’s *Renewal at the Heart of the Church* campaign, which launched its public phase in 2024. Generous benefactors who invest with the Knights of Columbus Charitable Fund have made extraordinary contributions towards the campaign’s success.

The Shrine of Our Lady of Guadalupe, La Crosse, Wisconsin

In a world marked by confusion, loneliness, and a growing forgetfulness of God, the Shrine of Our Lady of Guadalupe in La Crosse, Wisconsin stands as a living sign of hope.

The Shrine leads souls from across the country into the merciful love of God through the maternal care of the Blessed Virgin Mary, whose words to Saint Juan Diego, “Am I not here, I who have the honor to be your mother,” continue to echo in the hearts of those who visit.


As a place of pilgrimage, prayer, and conversion, the shrine fosters a renewed encounter with Jesus Christ through the Holy Mass, the Sacraments, Eucharistic adoration, and sound catechesis rooted in the traditional teaching of the Church.

Through the Blessed Mother’s intercession, hearts are changing. This was clear during our 2024 Nine-Month Novena and Consecration to

Our Lady of Guadalupe when more than 160,000 Catholics joined the shrine each day in prayer.

Throughout the nine months, families prayed together again. Parishes rediscovered Marian devotion. Individuals who had been away from the sacraments for years found the courage to return. The shrine became not just a destination in Wisconsin, but a spiritual home for Catholics across the country.

On December 12, 2024, on the feast of Our Lady of Guadalupe, thousands gathered at the Shrine for Holy Mass and the Act of Consecration. Many approached the image of Our Lady with tears of gratitude, entrusting their marriages, their children, their fears, and their hopes to her maternal heart. The atmosphere was one of profound reverence and joy – an unmistakable sign of God’s grace at work through Our Lady.



Your gifts sustain the daily spiritual life of the shrine, making possible the reverent celebration of the Holy Mass, extended opportunities for Eucharistic adoration, and the frequent availability of the sacrament of reconciliation.

Your generosity also protects and maintains the beauty of the holy grounds, allowing the shrine to welcome over 100,000 pilgrims each year. Families, the elderly, children, and those carrying heavy burdens find a refuge of peace because charitable gifts keep our doors open, the lights on, and the grounds reverently cared for.

Most importantly, charitable gifts support the shrine’s evangelizing mission. It helps us promote devotion to Our Lady of Guadalupe, defend the dignity of every human life, and strengthen marriage and family. The impact is measured not only in what is built or maintained but in the lives transformed, the families strengthened, and the faith renewed at the shrine.

One of the most significant initiatives now underway at the shrine is the National Prayer Rally, scheduled for June 13, 2026, during the 250th anniversary year of our nation. It will gather the faithful from across the country for a public act of prayer for America – for the Church, families, and a renewed culture rooted in faith and moral truth. The event is designed not only as a gathering, but as a call back to God – a reminder that true renewal begins on our knees.

Your donation to the Shrine of Our Lady of Guadalupe through Knights of Columbus Charitable Fund makes a profound and lasting impact. Your generosity ensures that the shrine will remain a place where pilgrims encounter Christ through the maternal care of Our Lady of Guadalupe.



SUPPORTING OUR COUNCILS

In 2021, our council started an account with KCCF. We use it to make donations to organizations whose purposes align with Catholic moral teaching. One of those foundations helps women with unplanned pregnancies by offering guidance and support. Another [foundation] advocates for people experiencing homelessness and others in vulnerable housing situations, providing emergency shelter, food and other services that affirm their dignity. These are just a few of the charitable organizations our council supports with grants through KCCF.

We rely on KCCF's due diligence to ensure all donations are made to organizations that uphold Catholic values. On a practical level, it eliminates the guesswork around assuring donors that their contributions are tax-deductible and in accordance with IRS regulations. As a result of these benefits, we have two major donors who make regular contributions to our council account.
