



## HOW TO MAKE A CONTRIBUTION

Knights of Columbus Charitable Fund serves as the fiscal sponsor for a variety of mission-aligned organizations and apostolates. As a fiscal sponsorship, we are able to facilitate tax-deductible donations to charitable organizations that do not have 501(c)3 status with the U.S. Internal Revenue Service.

Through our Fiscal Sponsorship program, KCCF provides fiduciary oversight, financial management, and other administrative services to help build the capacity of charitable projects. Donations to support the charitable project are made directly to KCCF, which in turn funds the project.

Below are instructions on the different ways you can contribute to a KCCF Fiscal Sponsorship organization.

*To ensure correct receipting and gift processing, complete a Donation Agreement. Failure to submit a Donation Agreement may result in delayed receipting or crediting to the organization's account.*
