Beatification brings to mind holiness of life and spiritual vision. This is the ideal moment to recall the spirituality of the young priest who spent his life faithfully serving the people of God and offering himself in sacrifice on their behalf while preaching the Gospel, teaching the truths of the Catholic faith, administering the sacraments and guiding his people in practical ways within a culture that was both anti-Catholic and anti-immigrant. In a short span of years, dying just after his 38th birthday, this holy parish priest accomplished more than many who live to old age. Father McGivney is best known for the two great graces of his life: First, he was a priest, a man set apart for the service of God and the salvation of souls; second, he established the Knights of Columbus, now a worldwide fraternal society for Catholic men with more than 2 million members. A society based on faith in action, his Knights have carried on his vision and mission to this

# A McGivney Miracle

'he healing of an unborn child from a fatal medical condition was the miracle approved by Pope Francis that opened the way for the beatification of Venerable Father Michael McGivney. The child was the 13th for Michelle and Daniel Schachle of Dickson, Tenn., in the Diocese of Nashville. Early in the pregnancy, a routine ultrasound revealed the boy had Trisomy 21 (Down syndrome) and a serious case of fetal hydrops, a relatively rare condition in which two or more major organs of the unborn child fill with fluid. The couple was offered abortion by doctors who said that the boy was sure to die in utero. A pro-life Knights of Columbus family, the Schachles declined abortion and prepared to accept whatever God would send them.

A general agent for the Order's insurance program in Tennessee, Daniel began to pray to Father McGivney with his wife, and asked their children, relatives, friends and colleagues to do the same. If the child survived, they promised to name him after Father McGivney.

In March 2015, Daniel embarked on a pilgrimage with fellow K of C agents to Fatima, and Michelle went with him after getting clearance from her doctors to travel. At the renowned Marian Shrine in Portugal, where the Blessed Mother visited three shepherd children and the Miracle of the Sun occurred in 1917, Daniel and Michelle experienced spiritual consolation and the hint of a healing. Still praying through the intercession of Father McGivney, the couple attended a Mass offered by Archbishop William Lori of Baltimore, the Order's supreme chaplain. The Gospel of the day,

read by Dominican Father Jonathan Kalisch, director of chaplains and spirituality for the Knights, told the story of the Roman official who asked Jesus to heal his son, who was sick unto death. When they heard the words of Jesus, "Go, your son lives," Daniel and Michelle looked at one another, and she felt "a veil" lifted from her.

After returning to Tennessee, Michelle visited her doctors for an ultrasound and was told that the child showed no signs of fetal hydrops. Without treatment or medical intervention of any kind, the child in the womb was healed of the fatal condition. Michael McGivney Schachle, affectionately called Little Mikey, was born May 15, 2015, and is now a healthy, active child with Down syndrome, surrounded by a grateful and loving family.

Word of the extraordinary healing reached the Supreme Council a few months after the child's birth, and the postulator of Father McGivney's cause, Dr. Andrea Ambrosi,

directed a preliminary investigation with the assistance of Vice-Postulator Brian Caulfield. A formal diocesan tribunal was opened in Nashville in April 2016 to investigate the healing, assess medical records and call witnesses with firsthand knowledge of the case, including the attending physicians. The tribunal concluded its proceedings in September 2017, when the full 700-page report, including testimonies and medical records, was sent to the Vatican's Congregation for the Causes of Saints. Over the course of more than two years, the congregation studied the case and convened

a board of medical experts who declared that the healing had no medical or scientific explanation. The congregation also referred to a panel of theologians who affirmed the exclusive intercession of Father McGivney. On May 26, 2020, the case was brought before Pope Francis, who approved the miracle attributed to the intercession of Father McGivney and declared that the founder of the Knights of Columbus could now be beatified, the last step in the canonization process before sainthood. The Vatican announced the Holy Father's approval the next day.

In his annual report at the Supreme Convention last August, Supreme Knight Carl Anderson said that the healing of Little Mikey was a true Knights of Columbus miracle, having involved the Order's commitment to protecting human life from conception to natural death, the dignity of persons with intellectual disabilities, the

## Foot Saved

On Easter weekend, I developed blood clots in my right leg which caused my right foot and toes to turn purple and black. day, reaching out to those in need, supporting and strengthening family life and the domestic church, and promoting Catholic values amid an increasingly secular culture.

Father McGivney's training for the priesthood was rigorous and intense. Seminary formation in his day emphasized the supernatural ideal of the priesthood and the need for the Catholic priest to be a man of discipline and spiritual depth. Seminaries in North America understood the priest as one set apart for the service of God. The central focus of this program was the role of the sacraments, especially the holy sacrifice of the Mass, Confession, Anointing of the Sick, and the typical prayers and devotions of that era. His daily prayers included the Divine Office in Latin, filling the hours with prayer and contemplation. Evidence of his piety was discovered during the initial exhumation of his body from the family gravesite in Waterbury, when a sewn image of the Sacred Heart of Jesus was found under his vestments along with a brown scapular and a white scapular, the latter worn by Third Order Dominicans.

Well aware of the prejudices and injustices suffered by many immigrants, the seminarian Michael brought to this training a heart made compassionate and sensitive to the sufferings of those around him. He understood the social ills that flowed from the poverty and family dysfunction common among those recently arrived on the shores of America. The priest Michael McGivney was exemplary as one steeped in a prayerful relationship with Jesus Christ and prepared to lay down his life for his neighbor.

Founding the Knights of Columbus flowed from his unwavering faith in the love of God and the mystery of the cross of Christ. "Greater love than this, no man has, than to lay down one's life for one's friend" (John 15:13). Inspired by the Holy Spirit, he organized a fraternal benefit society of Catholic men who would band together in faith and "lay down their lives" in generous service to those most in need. In turn, this would strengthen their appreciation for their lay vocation to become faithful and faithfilled husbands. Such "dying" would build up the family unit. The fraternity of the Knights would soon identify charity as its first principle.

Faith in Christ and his Church could, in Father McGivney's vision, become an instrument to transform the larger social structures beyond the parish, town, city or state. The founder intended that the influence of his fraternal society would have an impact beyond the borders of racial, religious or social stereotypes. The history of the Knights of Columbus proves the wisdom of the spiritual vision of this extraordinary parish priest and founder.

Father McGivney was a man ahead of his time. He anticipated the movement within the Church, expressed fully in the Second Vatican Council, to call upon the lay faithful to become more involved in the work of evangelization. He was a man of vision, a man of God, a founder and a priest. His beatification scheduled for Oct. 31 is surely a day the Lord has made.
